The purpose of this policy is to explain to you how we control, process, handle and protect your personal information while browsing or using this website, including your rights under current laws and regulations. If you do not agree to the following policy you may wish to cease using this website.

We are registered with the ICO under the Data Protection Register, our registration number is: 06952225.

Key definitions

"you" or "the user" refer to the person(s) using this website.

"GDPR" means General Data Protection Act.

"PECR" means Privacy & Electronic Communications Regulation.

"ICO" means Information Commissioner's Office.

"Cookies" mean small files stored on a user's computer or device.

Processing of your personal data

Under the GDPR, we control and process any personal information about you electronically using the following lawful bases:

Lawful basis: Consent

The reason we use this basis: To engage in communication between the user and the Company.

We process your information in the following ways: Personal Data will be sent to the relevant personal within FMCP only, in order to assist with the user's question or query.

Data retention period: We will continue to process your information under this basis until you withdraw consent or it is determined your consent no longer exists.

Sharing your information: We do not share your information with third parties.



Your individual rights

Under the GDPR your rights are as follows:

the right to be informed;

the right of access;

the right to rectification;

the right to erasure;

the right to restrict processing;

the right to data portability;

the right to object; and

the right not to be subject to automated decision-making including profiling.

You also have the right to complain to the ICO [www.ico.org.uk] if you feel there is a problem with the way we are handling your data.

We handle subject access requests in accordance with the GDPR.

Internet cookies

FMCP use cookies to help personalise your use of our sites. A cookie is a small piece of information which is sent to your computer's hard drive by the web server so that the website can remember who you are. For more information, please visit <http://www.allaboutcookies.org>. This information may include information relating to your use of our sites, information about your computer such as the computer's IP address and browser type, demographic data and, if you arrived at our site via a link from third party site, the URL of the linking page.

FMCP use information from cookies for purposes which may include:

- identifying users through their login details to manage their status within the site;
- confirmation that users have accepted the site disclaimer;
- enabling you to move more easily around our site; and
- tracking your use of our site to better develop our site in accordance with your requirements.

You can delete cookies from your hard drive at any time however this will mean that any settings such as your stored username and password will have to be reset. Google Analytics cookies

Essential Cookies

Disclaimer Cookie: this cookie is used to confirm that a user has accepted the website disclaimer. Cookie expires once the user logs off from the site.

ASP.NET_SessionID Cookie: this cookie is used only in response to actions by a user to the site which constitute a request for services, such as filling in forms. This cookie does not store any personal information. Cookie expires once the user logs off from the site.
